# Information for entering Japan (June 21, 2022)

### 1. VISA application (REQUIRED FOR ALL)

Currently visa exemption measures with the countries and regions listed in following website are suspended to avoid spreading COVID-19. Those who fall under the measures are required to obtain visas before visiting Japan.

#### 2-1. Procedures

#### "Fast Track" (RECOMMENDED)

You can complete quarantine procedures via app before entering Japan. This can reduce the process at the airport. <u>"Fast Track"</u> is available for those entering from <u>Narita International Airport, Haneda Airport, Chubu Centrair International Airport, Kansai International Airport, and Fukuoka Airport.</u>

#### 2-2. Documents

**<u>COVID-19 Negative Test Result Certificate before departure (REQUIRED FOR ALL)</u>** 

Everyone must submit a certificate of negative test result from specimen collected **within 72 hours prior to departure**.

Check the requirements carefully. The test result with only valid specimens and test method is accepted.

#### **Questionnaire** (REQUIRED FOR ALL)

Everyone must submit the Questionnaire via <u>"Fast Track"</u>. Issue a QR code after completing the Questionnaire, and present it to the quarantine station. If you don't use <u>"Fast Track"</u> app, you must complete the <u>Questionnaire on web</u> in advance.

# Please read the followings before applying the visa

- Since it takes time for visa application process, we recommend you to contact the Japanese Embassy/Consulate-General with jurisdiction over your place of residence immediately to ask the detailed procedure and what documents you need to prepare. In addition to the documents prepared by inviting person/guarantor in Japan, you may be required to present some documents. However, it depends on the local situation and the purpose of the visit.
- Please be sure that application of ERFS and preparation of visa documents do not guarantee entry into Japan. The visa application to Embassy or Consulate-General of Japan in your country should be proceeded on your responsibility. **TWHM2022** has no responsibility for cancellation of travel fees including flight tickets, hotel booking, etc. **TWHM2022** has also no responsibility for the case you are not be able to attend the conference due to the results of COVID-19 tests before and after your flight.
- Please be sure that it will take a week or more to prepare the requested documents in TWHM2022 and it will also take time to send them to you.
- Required quarantine and documents for visa applications depend on your departure country as well as vaccination certificates. Please confirm the requirements by your own responsibility.
- Kindly confirm in advance the details of your transit visa on your own responsibility when you travel to Japan via any countries. **TWHM2022** is not responsible on it. In addition, please check both the conditions and the period of quarantine of the transit country (countries) on your own responsibility.
- <u>Due to the border measure, eligible purposes of entering Japan is strictly limited. **TWHM2022** will not be able to apply ERFS if you include schedule other than the **TWHM2022**, guarantine period, or transit stay around the international airport during your visit to Japan.</u>
